HEALTHY RECIPE-Roasted Leg of Lamb with Rosemary

Ingredients:

- •5 lbs. leg of lamb
- •1/4 cup of honey
- •2 tbsp. Dijon mustard
- •2 tbsp. of fresh rosemary
- •1 tsp. ground black pepper
- •1 tsp. lemon zest
- •1 dash Worcestershire Sauce
- •4 cloves minced garlic
- ●1/2 tsp. salt

Directions:

- 1. Mix honey, mustard, rosemary, black pepper, lemon zest, salt, and garlic in a bowl
- 2. Preheat oven to 450 degrees and place lamb on a roasting pan. Bake for 20 minutes. Reduce heat to 400 degrees

time temperatures may still drop below freezing. Fortunately, our heating system is operating well.

If you have any questions or concerns about the system in your apartment, ask Bob Pattison.

For those of you that may want to get rid of any unwanted items from your apartment, please contact maintenance for assistance. We will haul these items directly out of the building for disposal without

obstructing the trash rooms. Let us know ahead of time if vou have items to discard.

The following is a reminder that may protect your safety and the safety of others. Syringes may not be thrown out with the trash without first following very specific requirements. First, the protective cap must be fitted properly over the needle. Next, the entire syringe assembly must be placed into a container with secure lid such as a detergent bottle or coffee can. When full, this closed container can be thrown out with your regular

trash. Additional information will be available from our resident services office.

Remember, if you need a repair within your apartment, please contact the front desk personnel to have a maintenance request filled out. We'll do our best to take care of these issues as soon as possible.

Late Fee and Rental Payment Reminder

The Compliance Office will begin working with Joan on the delinquency accounts monthly. Please be reminded that per section 4 of your lease: "If the Tenant does not pay the full amount of the rent shown in paragraph 3 by the end of the 10th day of the month, the Landlord may collect a fee of 5% of the total tenant rent amount on the 11th day of the month..."
