Reed Pest Control charges for cancellations. If you will not be available for treatment, do not request service. If you request service, and refuse treatment the day of— you will be charged the \$10.00 pest control fee.

Please remember that all trash MUST be bagged and put into the chute. Please do not leave trash on the floor. This is increasing problems with pests. Do not put unbagged items into the chute.
