MESSAGE FROM SOCIAL SECURITY Cost-of-Living Adjustment for 2024

Social Security & Supplemental Security Income (SSI) benefits will increase 3.2 percent in 2024. The 3.2 percent cost-ofliving adjustment (COLA) will begin with benefits in January 2024. Increased payments to SSI beneficiaries will begin on 12/31/2023. (Note: some people receive both Social Security and SSI benefits).

MEDICARE SUBSCRIBERS

Medicare Premiums for 2024 will increase to \$174.70 per month. Open enrollment for Medicare Coverage ends December 7th. This is the time vou can switch to a Medicare Advantage Plan -Medicare Plan C or D, return to straight Medicare, or just Enroll. The Effective date is January 1, 2024. It is wise to check if there are plans in this area that offers better health and/or drug coverage at a more affordable price.
